Applicants referring to the right to advantage in recruitment in accordance with Article 9 of the Vocational Rehabilitation and Employment of Persons with Disabilities Act besides the complete documentation are obliged to enclose a proof of established status of disability.

Applicants referring to the right to advantage in recruitment in accordance with Article 48 f of the Law on the Protection of Military and Civilian Disabled Persons of War besides the complete documentation are obliged to enclose a proof of established status.

Incomplete applications and applications submitted after the deadline would not be considered.

On the results of the selection, the applicants will be notified within 15 days of the decision making.

The Institute will use personal data of the applicants solely for the purpose of carrying out a tender procedure in accordance with the regulations governing the protection of personal data.

The applicants documentation or candidate data is kept six months after the end of the competition, and longer in case of a court or similar procedure, in which case they are kept until the end of the procedure.

After the expiry of the deadline of keeping the documentation, the documentation is destroyed, and each candidate can take his documentation after expiry of the deadline.
