- transcript of grades of all levels of study that the candidate has completed.

Advantage will be given to candidates who have experience of working in the media, especially in the mediation of music contents in the record companies or radio broadcasting companies.

## **Conditions for the candidates for the post under point 2:**

completed graduate degree of ethnology and cultural anthropology

Besides the written application, candidates have to enclose:

- CV in Europass form with short summary of a former scientific research and professional work,
- copy of diploma from the field of ethnology and cultural anthropology,
- transcript of grades of all levels of study that the candidate has completed.

Advantage will be given to candidates with the work experience or finished undergraduate or graduate studies in the field of visual arts or new media, as well as doctoral students.
